

During these tough times, it is important that we all work together. Unfortunately, scammers are taking advantage of these tough times and have increased their activity. According to the U.S. Secret Service, a well-organized crime ring is committing large-scale fraud against state unemployment insurance programs.

Here is what is happening. Individuals are receiving one or more automatic deposits from state unemployment insurance programs. The individual receiving the deposit is then being asked to forward the money to another person. The states involved include

Washington, Arizona, Florida, Maine, Massachusetts, North Carolina, Oklahoma, Rhode Island, and Wyoming. This is just a partial list and the list is growing by the day.

If you receive an unexpected automatic deposit, ask yourself the following:

- Are you eligible to receive the deposited funds?
- Is the deposit from the state you reside in, or is it from out-of-state?
- Did you receive a phone call or email asking you to withdraw/forward all or part of the funds to someone else?
- Have you been told you can keep part of the funds?
- Have you been told not to let your financial institution know why you are withdrawing the funds?
- Were you a victim of a previous scam?

If you received an unexpected automatic deposit, especially from a state unemployment program, and answered yes to any of the questions above, please contact your local TCCU office immediately.

It is unfortunate that there are people who take advantage of times like these to scam unknowing individuals. Do not ever give out your personal information to anyone unless it is for a transaction you initiated and you are 100% sure you are dealing with someone who is reputable. If someone contacts you asking to have funds deposited into your account, that you are then supposed to forward on to someone else, it is a scam.

Please don't hesitate to call us if you have any questions about transactions in your account, or if you suspect you might have been contacted by a scammer. We are here to help.

LETTER FROM THE PRESIDENT

PLEASE NOTE: CHANGES TO FUNDS AVAILABILITY

Effective July 1, 2020, the following changes were made to our Funds Availability Policy.

- The amount available for withdrawal for checks not subject to next day availability has increased from \$200 to \$225.
- The amount available for withdrawal on exception holds for large deposits and new accounts not subject to next day availability has increased from \$5,000 to \$5,525.
- The threshold for determining a repeat overdraft has increased from \$5,000 to \$5,525.
